Basis of Preparation

The entity has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting Tier 3 - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

Goods and Services Tax (GST)

The entity is not registered for GST. Therefore all amounts are stated inclusive of GST (if any).

Income Tax

Ni Hao Children's Community Charitable Trust is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

Changes in Accounting Policies

There have been no changes in accounting policies. Policies have been applied on a consistent basis with those of the previous reporting period.

- (1) The monthly \$3,000 or \$2,000 private donation to the charitable trust that occurred throughout 1 April 2015 to 31 March 2016, will not be continuing past 31 March 2016.
- (2) The Playgroup stopped operating in June 2015.
- (3) There have been frequent teaching staff changes during the financial year. Two part-time staff departed in 2015, with two new part-time staff joining in 2015. One new staff member joined at the start of 2016, with one also departing at the start of 2016. One part-time staff member has subsequently moved into full-time hours during the new 2016/17 financial year.
